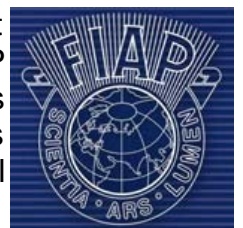

BREAKING NEWS FROM FIAP

There has been some concern amongst Exhibition Organisers and Entrants about some of the new FIAP rules and criteria to achieve their distinctions. The PAGB, WPF and SPF made a joint approach to FIAP with several suggestions. The FIAP Directory Board, met in late February and whilst there is nothing out yet on paper **e-news** can share the following information.

The PAGB FIAP liaison Officer, Dave Coates, is disappointed (but not surprised) that our suggestions for transitional arrangements in relation to the new criteria for EFIAP Levels Distinctions have not been acted upon. However, the 10% limit on acceptances from any one country for all FIAP Distinctions has been relaxed to 15%. Whilst this is not as flexible as we sought, it will at least help some applicants and may be a partial relief to many salon organisers.



Whilst many will be disappointed that we did not achieve more, our cause was not helped by PSA announcing four new awards, GMPSA/b (5,000 acceptances), GMPSA/s (7,000), GMPSA/g (9,000) and GMPSA/p (11,000). FIAP's 1,500 acceptances for EFIAP/platinum does not now appear to be so drastic, even though it may still be so to many exhibitors.

Following the PAGB guidance on data protection, Harrow CC has an example of how short an actual club policy can be. Although the Club believes this to be perfectly adequate and you may wish to adopt it, Mark, Harrow CC or the PAGB can take no responsibility for its adequacy or accuracy.

HARROW CAMERA CLUB Data Protection Policy

The Club complies with the Data Protection Act 1998. Under the Act, the Club is a data controller exempt from notification.

The Club collects and holds personal information about members. This includes name, address, telephone number, e-mail, membership duration, scores obtained in competitions, records of work shown at external competitions, and permission to use images on the web site. Any member wishing to verify the personal information held by the Club should apply to the Secretary.

Personal contact details are used only for the administration of the Club, and are distributed only to Committee members, and to others approved by the Committee for specific purposes.

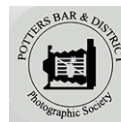
Contact details may be held about prospective members while they decide whether to join. Contact details are held about previous members for 1-2 years, in case they decide to re-join.

We are still hearing misquotes of this definition, even from experienced judges, so we thought it worth publishing again.

DEFINITION OF NATURE USED IN PAGB COMPETITIONS.

Nature photography is restricted to the use of the photographic process to depict all branches of natural history, except anthropology and archeology, in such a fashion that a well-informed person will be able to identify the subject material and certify its honest presentation.

The story telling value of a photograph must be weighed more than the pictorial quality while maintaining high technical quality. Human elements shall not be present, except where those human elements are integral parts of the nature story such as nature subjects, like barn owls or storks, adapted to an environment modified by humans, or where those human elements are in situations depicting natural forces, like hurricanes or tidal waves.

Scientific bands, scientific tags or radio collars on wild animals are permissible. Photographs of human created hybrid plants, cultivated plants, feral animals, domestic animals, or mounted specimens are ineligible, as is any form of manipulation that alters the truth of the photographic statement.

No techniques that add, relocate, replace, or remove pictorial elements except by cropping are permitted. Techniques that enhance the presentation of the photograph without changing the nature story or the pictorial content, or without altering the content of the original scene, are permitted including HDR, focus stacking and dodging/burning. Techniques that remove elements added by the camera, such as dust spots, digital noise, and film scratches, are allowed. Stitched images are not permitted. All allowed adjustments must appear natural. Color images can be converted to greyscale monochrome. Infrared images, either direct-captures or derivations, are not allowed.

Images used in Nature Photography competitions may be divided in two classes: Nature and Wildlife.

Images entered in Nature sections meeting the Nature Photography Definition above can have landscapes, geologic formations, weather phenomena, and extant organisms as the primary subject matter. This includes images taken with the subjects in controlled conditions, such as zoos, game farms, botanical gardens, aquariums and any enclosure where the subjects are totally dependent on man for food.

Images entered in Wildlife sections meeting the Nature Photography Definition above are further defined as one or more extant zoological or botanical organisms free and unrestrained in a natural or adopted habitat. Landscapes, geologic formations, photographs of zoo or game farm animals, or of any extant zoological or botanical species taken under controlled conditions are not eligible in Wildlife sections. Wildlife is not limited to animals, birds and insects. Marine subjects and botanical subjects (including fungi and algae) taken in the wild are suitable wildlife subjects, as are carcasses of extant species. Wildlife images may be entered in Nature sections of Exhibitions.

NOTE. This is now a definition agreed by FIAP, PSA and the RPS as well as the PAGB and its Federations.

PRINT MOUNTING by CLUBMAN

Quite suddenly the projected digital image displaced the transparency as a way of displaying our work and it seemed likely that mounted prints might decline in popularity. That does not seem to have happened and prints retain an important place in club competitions and in exhibitions. The computer controlled screen display has obvious merits but it lacks the opportunity for the more leisurely study offered by prints on a gallery wall.

As a result, the craft activity involved in mounting prints has endured. Many photographers take pleasure in this but for some it is just a troublesome chore and that often shows in their results.

Most judges have had to juggle with poorly mounted photographs. Masking tape comes away and sticks to the fingers. (This product is **designed** to come unstuck). A backing board the same size as the mount may have been assembled with double sided Sellotape which either dries out or can't cope with such heavy duty and the assembly falls apart. A badly secured print may move in the mount and look very sad.



Along with all of this, downright carelessness can ruin things. A jagged aperture may look as if cut with a blunt knife, be out of square or, perhaps, of the wrong proportions.

Does a badly mounted print influence the judging process? It would be good to think that it doesn't but first impressions are difficult to ignore. Most make sure their car is clean when it goes for its MOT, even if cleanliness is not part of the assessment.

Strongly coloured mounts almost never work. The mount is there to support and complement the picture - not to compete with it.

In the interests of economy, it might be tempting to reuse the same mount for more than one photograph. That's fine if the size and proportions of later pictures are exactly the same as the original but it fails completely if there is an obvious misfit, showing unwanted white margins on two edges, which is what sometimes happens. It's also time to dump the old mount when the corners have been damaged or other signs of wear and tear begin to show.

Pity the long suffering judge who has to contend with all of this and more besides. Where a backing board the same size and thickness as the mount is used, so as to double the thickness of the 50 x 40cm assembly, it adds weight. Not a problem for just one picture but a club competition might include at least seventy five prints and the collection, contained in two boxes, will weigh nearly 36kgs (70lbs).

Weightlifting is not part of a judge's training.
